Question Two

In each of the following cases, indicate and explain whether Nothando has approached and instituted action in the proper Court.

- i) Nothando's deceased father left her substantial property in terms of a written will prior to his death. Nothando's elder sister, Thandiwe, claims that the will prepared and executed by their father is invalid because it was made while their father was under duress. Nothando approaches the Magistrates' Court for an order declaring the will to be valid.

- ii) Nothando has been divorced from her husband in terms of the Marriage Act. Her former spouse, however, has been neglecting to pay her maintenance for a lengthy period. Nothando now wishes to claim arrear maintenance totaling Z\$12 million and approaches the Small Claims Court [5 marks]
- iii) Nothando is charged of armed robbery in the Regional Court. She is convicted and sentenced to a lengthy term of imprisonment. Nothando wishes to appeal against the decision and lodges her appeal with the Supreme Court of Zimbabwe. [5 marks]
- iv) Two (2) of Nothando's tenants in Bulawayo have failed to pay her the rent for over two months now. In addition, these two tenants have been conducting illegal activities at the premises that Nothando has leased out to them. Nothando is advised to evict these tenants and commences action in the Bulawayo High Court. [5 marks]
- v) After Nothando's divorce, she gets acquainted with Themba and thereafter decides to get married to him customarily. She goes with Themba to his rural home and they get married at the Customary Local Court. [5 marks]
