#### **SECTION A**

- 1. Assume that you are ZIFA class two referee and you have been appointed to officiate at a ZTISU group match between the National University of Science and Technology and Hillside Teacher's College. What decisions would you make in each of the following circumstances? Justify your decision.
  - a) As you are inspecting the field just before kick-off your discover:-
    - ZIFA and FIFA banners and logos on the goal nets and corner flags.

ii) Commercial advertising one meter from the boundaries of the field.

iii) That the field is marked with broken lines.

- b) i) The ball becomes defective during the course of the match. (2 marks)
  - ii) An extra ball enters the field of play during the course of the match.

c) i) A National University of Science and Technology player changes places with goal-keeper without informing you and goes on to make a brilliant save.

(3 marks)

ii) You send off a Hillside player and one of the National University of Science and Technology named substitutes before kick-off for unsporting behaviour.

- iii) A National University of Science and Technology reveals undergarments showing political slogans after scoring a goal. (2 marks)
- d) i) A Hillside player scores an own goal from a direct free kick. (2 marks)
  - ii) The National University of Science and Technology goalkeeper takes a throw in and after the ball is in play he deliberately handless the ball inside his own penalty area before it has touched another player. (2 marks)
- e) i) You are required to restart play with a dropped ball and the ball goes out of the field of play before it makes contact with the ground without any player

touching it. (2 marks)

- ii) A National University of Science and Technology defender trips a Hillside striker inside the penalty area when the ball has already gone out of the field of play. (2 marks)
- 2. a) Explain any three circumstances under which a player in an off-side position may be penalized for being in that position. (6 marks)
  - b) Outline the ten offences for which a penalty may be awarded. (10 marks)
  - c) Discuss the offences for which a player substitute and substituted player may be send off and shown a red card. (9 marks)

#### **SECTION B**

- 3. Discuss the historical evolution systems of play in soccer form 1870 to the present day. (25 marks)
- 4. Assume that you are the Course Director for a Level one soccer coaching course and you have been tasked to facilitate on a section dealing with why it is important for a soccer coach to have a knowledge and understanding of the four basic management functions of planning, organizing, leading and controlling.
