ANNEXURE A

You are a reporter for the daily *Bulawayo Gazette*. You receive the following information about a demonstration held in the Bulawayo city centre this morning:

Statement from Lizwe Mhlope, a lawyer and eyewitness

Everyone, pedestrians, drivers and cyclists, just stopped and stared. I've never seen such a sight in my entire life. There was a line of empty cars along Fife Street; the drivers were all standing on the street trying to get a better view.

Everyone was mesmerised, even the riot police. When the women finished their business and started going off, I could see some of the riot cops laughing and shaking their heads. Then they got into their trucks and drove away. After that, it was like everyone else woke up from a stupor and got back to what they were doing before all this started.

Statement from Millicent Moyo, a vegetable vendor and eyewitness

I was at the ATM outside Standard Chartered Bank along Fife Street, around nine in the morning, when I heard singing. I saw a group of naked women – there must have been close to a hundred of them – walking along Fife Street, towards the bank, singing and dancing and waving placards. I couldn't believe my eyes. They stopped outside the bank and one of the women, their leader, I guess, started giving a speech about this ridiculous mini-skirt law they want to introduce.

When the police came, they just seemed stumped. They didn't seem to know what to do.

Statement from Amanda Hlatswayo, a shopkeeper and eyewitness

Everything just came to a standstill. Then the police came and tried to arrest them and that's when things got even more bizarre. First, one police car came along and a group of officers tried to talk to the women, but there was so much noise because of the singing that I don't think they heard a word he said. They just kept going, singing and dancing, like the cops weren't even there.

Then the riot police came, but they couldn't get through all the cars and people blocking the street. They just stood and watched like everyone else as the women gave their speeches and sang songs and danced. I think we must have been there for about an hour. When they finished, they took clothes from these bags they were carrying, got dressed and just walked away.

Statement from police spokesperson, Thabo Ncube

Yes, I can confirm that such a development did take place. We're looking into it and will provide more information when we have it.

Background Information

The Public Dress Code Bill has been brought before Parliament. It proposes the introduction of a dress code that will "protect public morals". Among the proposals contained in the Bill is a ban on the public wearing of mini-skirts. Women's groups have criticised the proposed law, calling it an attack on the rights of Zimbabwean women.
