What ethical problems arise from this situation?

c) Read the following story and answer the questions below.

In 1987, *The Tampa Tribune* published the name of Eliana Martinez, a child involved in a highly publicised struggle for entry into the public school system. The *Tribune* made the difficult decision despite impassioned entreaties from Eliana's mother Rose Martinez, who feared her daughter – who is mentally retarded – would be mercilessly harassed. Rose adopted Eliana as a baby from her native Puerto Rico, where the child had contracted the AIDS virus from blood transfusions. Through intense love and attention at her mother's home, Eliana evolved from a mute, staring vegetable to an active, laughing child – though one without the ability to speak, read or control her bowels. With fierce resolve, Rosa entered into a fight with the school board to have Eliana placed in special-education classes – the only place, she felt, her daughter would reach her full potential. The school board, fearing Eliana's lack of toilet training would pose a health threat to other children and teachers, denied the request.

Lawrence McConnell, the assistant editor ordered that the child's full identity be revealed and the next morning the story was published with all the details. His argument was that Rose had opened the case to the public, therefore, anyone who wanted to could attend the hearing and learn the child's name. He also believed that the story was of public interest and the mother wanted to take too much control over the media in an attempt to further her own agenda.
